

Within 15 days of the date of issuance of the order, the Sign shall join and report to the Chief Medical & Health Officer/Civil Surgeon cum Superintendent and complete 15 days of training at the District Hospital. On completion of the stipulated period of training, Sign shall join/report at the institution of his posting, and deliver required services. The tenure of the post shall be one (01) year from the date of joining. Failure to join/report within the stipulated time period of 15 days, will indicate that the Sign has not executed the bond, and the State shall take appropriate action.
2. During the tenure of the bond, the Sign shall receive fixed monthly honorarium of Rs, 26,000/- (rupees twenty six thousand only).
3. Additionally, the sign will be eligible for One (01) Casual leave per month and Maternity Leave as per norms. Apart from the above mentioned leaves, the Sign will not be eligible for Earned Leaves (EL) and extraordinary leave. Maternity shall be excluded for calculation of Bond period.
4. The Sign shall maintain daily work diary in the approved format. The daily work report shall be mandatory uploaded online every week.
5. The State Government may terminate the requirement of compulsory service 07 days after service of notice to the Sign. The Sign shall not discontinue services during the tenure of the bond. Any discontinuation of services will be repudiation of the agreement.
