MPPHSCL on behalf of Department of Public Health & Family Welfare, Government of Madhya Pradesh and State Health Society,(National Health Mission ,Madhya Pradesh) intends to set up an integrated GIS/GPS controlled Integrated GIS/GPS Mobility vehicle system for total control of movement and generating centralized log of tracking of all Integrated GIS/GPS Mobility vehicle i.e. Mamta rath & RBSK vans fitted with GIS/GPS in the State of Madhya Pradesh for engagement on retainership basis.

. The organization should be capable to monitor through GPS/GIS and handle around 1000 ambulances. All Integrated GIS/GPS Mobility vehicle logs to be created and monitored centrally by the organisation. For Selection of partner for setting up and time to time Up-gradation of GIS/GPS based Dial system of Health , Department of Public Health & Family Welfare ,Government of Madhya Pradesh for monitoring movement of all Mamta Rath and RBSK vans.

In this regards, MPPHSCL is looking for a partner who is willing to participate and operate the same project for a period according to tender terms. Bidder who has a prior experience of similar work & willing to work with MPPHSCL on exclusive basis may submit their willingness along with below mentioned documents latest by Feb 19th , 2015 upto 3:00 PM.

Objective: The sole objective of this document is to solicit Expression of Interest (EoI) from eligible System Integrators to be short-listed for consideration for a further bid process, wherein a Request for Proposal (RFP) would be issued to the short-listed System Integrators based on the evaluation of EoIs, for selection of a system integrator for implementation of the Project.

Qualification: The bidder is required to meet the following criteria and submit documentary proof along with the offer:

1. Bidder should be a company, and should have been in existence since the last 3 years. (Companies should have a Certificate of Incorporation as a proof of existence of the Company for the minimum period of 3 years).
2. Company Profile along with bidders average turnover should be at least Rs. 100 Crores in the last three financial years (audited balance sheets and P&L account are required to be

submitted).The turnover refers to standalone of the company and not the group turnover of its subsidiaries/sister concern etc. for year 2012-13, 2013-14 & 2014-15 however, if audited financial report for the year 2013-14 is not available, unaudited report certified by the Chartered Accountant may be considered.

Company should have positive net worth in consecutive last two years (copy of same certified by Statutory CA is required to be submitted).

3. No bids directly from any Firm / Agency / Joint Venture / Consortium of Companies outside India would be accepted.

4. The bidding Firm / Agency or the leading firm in the Joint Venture or Consortium of Companies should have been in the business for a minimum period of 3 years. (Certificate of Incorporation or CA certificate is to be submitted).

5. Joint Venture / Consortium of Companies can have a maximum of 3 members. In addition, total stake of Indian Co. / Cos. in Joint Venture / Consortium of Companies to be 51% or more with management control in Joint Venture to be with an Indian Co and with an Indian Citizen.

6. The Bidder shall give his willingness to give the services on exclusive basis.

7. The firm / agency / joint venture / consortium of companies shall not attract conflict of interest in principle.

8. The bidder/ The firm / agency / joint venture / consortium of companies shall have experience of execution of at least 1 (one) no. Dial or similar Projects in any State Health project in India.

Note: It is mandatory to enclose copy of purchase order (s) and completion certificate (s) as a proof of experience with the offer otherwise offer will not be accepted.

9. Bidder should have valid ISO certificate, company registration certificate, valid sales tax registration certificate and valid service tax registration certificate etc.

Existence for not less than 3 years.

10. Bidder should be ready to payment terms and all other conditions as per the tender terms.

11. The bidder should submit declaration stating that in case of award of contract, the bidder should be ready to submit irrevocable BG as 10% of total awarded value of bidder.

12. The selected party shall have to sign the Integrity Pact with MPPHSCL.

13. Compliance of all the above documents should be submitted on bidders letter head along with the bid in the tabular format with the relevant documents with a soft copy in CD. The CD must have

a presentation of the project on Company profile, key personnel, method , support, team, manhours and timelines to start the project. To provide short introduction of organization with organogram and names and contacts of lead personnel. (max 15 slides PPT)
