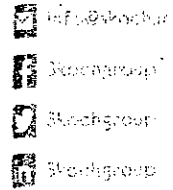
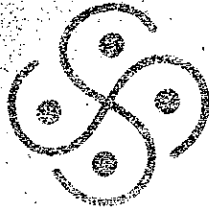

Dear Mr Kamal,

I enclose our State of Governance Report Card for 2017. You may find the full report on your state on page 32.

The total awards won by your state between April '14 to March '17 are 111, which puts you at #3 position nationally. For the period April '17 to December '17, the ranking of Madhya Pradesh has slipped to #7 nationally. Madhya Pradesh has received 22 awards within this period. Given my own experience of Madhya Pradesh, I feel that there is considerable scope of improving this rank.

Other states, including the top three states in our ranking, have been continuously nominating a large number of well performing projects for evaluation. These include #1 Rajasthan (58 awards), #2 Telangana (43 awards) and #3 Maharashtra (36 awards) within the same period. Please find enclosed some media coverage on the same.

A larger number of nominated projects enables a meaningful study of the initiatives being undertaken by the state and an effective comparison with other states.

This year as a run-up to the elections, we expect the competition to be intense. Based on our research and estimates, we believe that this year the range of cumulative number of awards required to make it to the Top-10 list would be more than 150 to 280 awards to touch between #10 to #1 rank.

For Madhya Pradesh, it may mean a minimum of 70-odd award-winning projects to get back to the #3 rank and more if the state were to improve its rank. In our experience, 30%, out of the well performing projects that are nominated, tend to attain the SKOCH Order-of-Merit Award and 10% or so, finally go on to win the SKOCH Governance Award.

Given that the awards cover all aspects and tiers of governance and not just IT, many states have taken extensive initiatives to make the nominations a government-wide effort. I enclose, for instance, a letter issued on behalf of Chief Secretary, Uttar Pradesh, who has taken the Call for Nomination across Departments including the Districts as well as Municipalities. This then can result in the best of each Department, Municipality and District being offered for evaluation.

Nominations can be filled online at www.skoach.in. The last date to submit the nomination is 30th April 2018. As always, I look forward to a great concerted effort from Madhya Pradesh. I await your feedback on the enclosed issue of INCLUSION.
